As an applicant to bow hunt for deer within Black Hawk County Conservation, George Wyth State Park, Waterloo, Cedar Falls, ~~University of Northern Iowa~~, Evansdale, Elk Run Hts., Big Woods Lake & San Souci Island you must:

- Possess a valid deer hunting license from the Iowa Department of Natural Resources (DNR)
- Pass an approved International Bowhunter's Education Foundation (IBEF) safety education course
- Pass a bow hunting proficiency test with at least 80 of a total score of 100 (to be updated annually)
- Obtain written permission from the private property owner (annually). The property must be located within a "Deer Management Zone" as established by the Black Hawk County Deer Management.
- Take all bow and arrow shots from a ground or elevated (Evansdale) stand and shoot no further than 60 feet (20 yards)
- Not take shots within 25 yards of any recreational trail, bicycle path, street or road
- Not take shots within 200 feet (66.6 yards) of a home or building
- Recover and remove all deer carcasses shot
- Follow DNR hunting guidelines
- No stalking or driving of deer is allowed
- Hunters will carry their bow in a case to and from the stand
- Report all deer taken at check-in stations
