#### **Camper Expectations and Agreement**

Basic rules that all campers must follow are: 1) They may not hurt or endanger themselves.

2) They may not hurt or endanger others. 3) They must stay with the group. 4) They must respect all others as well as nature. 5) No foul language or threats (verbal or physical) allowed.

6) Campers are expected to participate well with others and follow safety rules.

#### What to Expect

**Food & Water:** With the exception of our preschool camps, we ask that all campers <u>bring a water bottle</u> and a sack lunch for each day of camp. Please put names on lunches! If your child has a special food allergy please note on the Camper Information Form. Water stations to refill water bottles will be set up throughout the camp area to ensure proper hydration during the summer weather.

**Equipment:** Personal items that are handy include a water bottle, a lunch, a hat, insect repellant and sunscreen. Please put your child's name on these items too.

**Clothing:** We will be actively exploring the outdoors and there is an excellent possibility that your day camper will get dirty. Please make sure that your camper is dressed in long pants and closed toe shoes. <u>Sandals are not allowed</u>. We plan on going outside everyday, so day campers should be dressed for the weather (even rain). You may pack an extra set of clothing (just in case). Please mark everything with your child's name.

**Drop Off & Pick-Up:** Please be prompt in dropping off and picking up your day camper. <u>Children may not arrive</u> <u>before the start of their respective session and must be picked up promptly.</u> You are required to remain with your child until the staff opens the camp each day. Your child will not be released to anyone other than a parent/guardian unless you notify the staff ahead of time. We wish to avoid any potential accidents in the parking lots, so please escort your child to and from the Lodge.

**Weather Procedures**: 1) A weather alert radio is on during camp operation. Staff will respond accordingly when alerts are announced. Staff also carry cell phones and/or radios at all times; if on the trails, staff maintains contact with reception staff who monitors the weather radio. 2) If a warning is issued for our area, we will move the children to a place of safety within our building and staff will be responsible for helping to calm children until threat has passed. 3) At the first sound of thunder or first sighting of lightning, all children will be required to head indoors and remain there until the threat is gone. Staff have appropriate indoor nature activities for such times.

#### Refunds

Camp Registration fees are due within two weeks of the confirmed reservation. If a camper must cancel a reservation prior to the beginning of camp, they are required to notify the Pottawattamie Conservation Education Staff immediately. A refund of the registration fee will be based upon the following schedule:

14 days (or more) notice	50% refund	13-8 days notice	25% refund
	7 days or less notice	no refund	

#### Cancellations

If any camp has less then 10 registered campers it may be cancelled and a 100% refund will be issued.
